IUMI's Articles of Association

Amendment to Article 5 § 2:

Not less than two of the Vice Chairmen shall retire annually, but shall be eligible for re-election; however, the term of service for the Vice Chairman should not exceed three years. In exceptional circumstances, and upon the recommendation of the Nominating Committee, the term of service of a Vice Chairman may be extended, subject to the vote of the Open Council.
